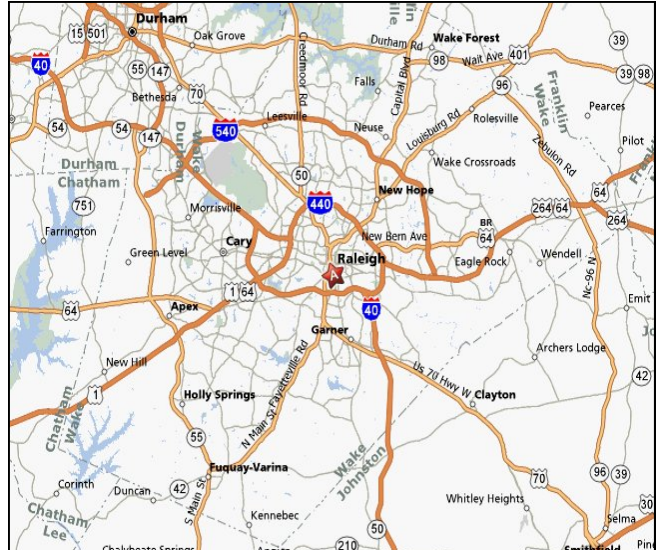

## Non-Disclosure and Confidentiality Agreement
